


Exercise Room



He called the credit card company and started yelling at them, saying that he did not make the transactions. Customer care personnel verified that there was no mistake in the system and asked if his card had been stolen. "No," he said, but then took out his wallet, pulled out the credit card, and yep - you guessed it - a switch had been made. An expired similar credit card from the same bank was in the wallet. The thief broke into his locker at the gym and switched cards.

Verdict: The credit card issuer said since he did not report the card missing earlier, he would have to pay the amount owed to them. How much did he have to pay for items he did not buy? \$9,000! Why were there no calls made to verify the amount swiped? Small amounts rarely trigger a "warning bell" with some credit card companies .It just so happens that all the small amounts added up to big one!



LOOSEN UP!

LOOSE is definitely in—at least, when it comes to the contents of our recycling bins.

My apologies to the vast majority of you who follow the rule.

However, a casual inspection of our recycling bins on any given day usually reveals the presence of a number of plastic bags containing presumably recycling materials.

This is unhelpful to the sorting process to which all the content of the recycling bin must be subjected. The sorting process is geared to handle LOOSE materials. Having to open and empty plastic bags is an impediment to the functioning of the process. The plastic bag itself is a contaminant since it can not be recycled by the City of Toronto. Often the easiest way for the City to deal with bagged materials is to discard the unopened bay and treat it as garbage.

SO, please empty those plastic bags when depositing your recyclables into the recycling bins. You can deposit the plastic bag into a brown garbage bin—a knot or two in it would discourage its being blown away by the wind.

Even better, put it into your pocket for later re-use or, if is clean, take it to a Dominion Food Store for recycling.

Those of you who are aware of this problem which probably include most of the readers of this article, could help by spreading the word to your friends. Some people are just simply unaware of it.

You are invited—whether owner or tenant—to a residents' meeting in the recreation room (B1). The purpose of the meeting is to talk about Bylaw Revision, and here's the background

Our board has been advised by our lawyers that the rules which govern 40 Homewood and which are found in your little yellow book (entitled Condominium Documents) are sorely out of date. In fact, these documents have not been revised since they were written in 1972.

Some of the articles in our bylaw no longer conform to the most recent Ontario Condominium Act, others have been found illegal, while still others are no longer necessary.

To assist this process, three of us have decided to form a Residents' Bylaw Revision Group, and the November meeting will be the first of several open, public meetings to discuss the issues at hand. We need to hear from you, the residents, about the matters which are of concern to you and which might be subject to a new rule or regulation.

At the meeting, we shall introduce ourselves and tell you why this matters to us. We will also outline the hierarchy of rules which govern us, from the Condominium Act to the Rules and Regulations. We will tell you how things stand now, and what we would like to achieve by the time of the next AGM in June 2008.

Bylaw creation and passage is complicated, and with good reason. One must be thoughtful and conservative in offering changes. Any suggestions this group makes must go to the Board for approval. Then, the suggested changes and additions must be approved by 50+1 percent of the owners. After that, they must be registered and only then do they take effect.

So please, do think about what would make living at 40Homewood more amenable to you and come to the meeting. We can't please everyone and we won't all agree, but we should have a good time, thinking about our home and its future.

Pumpkin Crunch

- 1 1lb (13oz.) Can pumpkin
- 1 12oz. can evaporated milk
- 1 cup sugar
- 3 eggs
- 1 teaspoon cinnamon
- 1 box yellow cake mix
- 1 cup nuts chopped
- 1 cup melted butter

Mix first five ingredients and pour into greased, parchment lined 9X13 cake pan. Spread half of cake mix (dry) over batter, sprinkle with nuts and remaining cake mix. Pour melted butter over top. Bake in 350° oven for 50 mins. When cool, loosen pumpkin crunch from side of pan with a knife. Invert pan into platter (the top becomes the crust) Top with sweetened cream cheese or whipped cream
